**VI. Health Commissioner:** Mr. Migliozi submitted a written report to the Board for their review. In addition, Mr. Migliozi reported the following: The Ohio Association of Boards of Health are holding their annual meeting on 9/16/17, in Delaware county, and they are encouraging all health departments and boards of health to attend. If anyone is interested in attending, please let Mr. Migliozi know. The tentative date to receive the vehicles is 9/5/17. Sharon O'Donnell was named Employee of the Month for August, and was presented a certificate. The Board congratulated Mrs. O'Donnell, and thanked her for her hard work. The installation of the fiber optic line has been completed, and this should improve the health department's internet connection and address the problems that staff was having with the telephones. It should only take another week to have all the documents uploaded to PHAB for our accreditation. There have been human cases of West Nile Virus reported in Clermont and Lucas counties. Arrangements are being made to do trapping for mosquitoes locally.

At that meeting, the Board tabled any action regarding the variance. Mr. Johnson did not submit paperwork to allow consideration of keeping the wells for historical reasons, nor were we able to obtain a safe water sample on the wells; therefore, since findings & orders had been issued against this property in

December 2016, which ordered sealing of the wells, the health district is going to proceed with filing charges in court.

## Health Commissioner's Report –July/August 2017 Board of Health Meeting

### 1) Budget/Financial

- As of 7/31/17, our general fund balance was positive \$86,505.31, which is up from your May financial report, which showed a \$76,515.00 negative balance. The shift can be attributed to the steps that I have outlined to you most of the year, which included monthly transfers from the grants, inter-fund reimbursement transfers from other funds and the recent receipt of incentive bonus funding from Help Me Grow of approximately \$86,000.00. The general fund has continued to stay positive for the month of August, and for the most part all funds currently have a positive balance. Our all fund balance is currently approximately \$950,000.00, which equates to approximately two months of funding reserves.
- Our Welcome Home Fund, 967, was recently combined with our General Fund, 950. This change was made due to the fact that Fund 967 was in essence a general fund for the nursing division. We checked with the state auditor's office prior to combining these funds and they stated, in writing, that it would be acceptable to combine these funds.
- The 2016 financial audit is still not complete, but we are hopefully that it will be completed shortly, but we have no completion date as of yet.
- The county commissioners' office informed us last month that we needed to write our own bid specifications for contracting with a company to supply a credit card payment system for the health district. We supplied the county with the bid specs, a legal notice has been published, anyone wishing to bid must make written notice to the county commissioners by noon on Friday, 8/25/17, and bids will be accepted until 4:00 PM, 9/18/17. We are hopeful that we will be online to accept credit card payments in the fall.

### 2) Time Study

- Attached is my time study for the month of June & July. The bulk of my time has been spent on administrative issues, PHEP, food service and budgetary issues.

### 3) Vehicles

- The vehicles still have not arrived. We have reached out to the dealership, but have not received an anticipated delivery date as of yet.

### 4) Accreditation

- We are nearing completion of the uploading of documents to PHAB of the 12 domains. We have two domains left to upload. We had a delay due to the expiration of a majority of the documents in Domain 1, and a good number in Domain 3. The Domain 3 documents were linked, where several examples had to be related to one specific document. Once the main document expired, all of the related documents had to be replaced also. The Domain 1 documents that expired had to be dated within 14 – 24 months of the submittal date.

### 5) Surveys

- The Ohio Department of Agriculture recently completed their survey of our retail food establishment program, and placed us on the approved list; however, we have to work on an action report for some items that they would like us to improve upon.
- In addition, the Ohio EPA completed their survey on our solid waste and construction & demolition debris programs. Although we have not received official notice, the surveyor indicated that she was very pleased with our administration and enforcement of these two programs by our agency.

### 6) Mobile Pediatric Unit

- I am continuing to meet on a monthly basis, in person or via conference call, with Akron Children's Hospital on a mobile pediatric unit that will service the area of Mahoning and Trumbull counties. Specifically, the committee is looking to have the unit work in conjunction school districts in Trumbull and Mahoning counties to provide essential services to needy children right on school property.

7) **Trumbull County Drug OD Epidemic**

- As you are aware, over a year ago, the health district received funding from the state to combat the opioid and overdose epidemic plaguing our county. One of the provisions within that grant was to form an overdose review committee, which we have had in place since that grant's inception. Our original intent was to meet twice a year; however, with the high number of overdoses occurring each month, we have decided to meet on a monthly basis. The purpose is to track the overdoses at more frequent intervals so we can identify trends, and amend current strategies to address this issue at a more rapid rate.
- Sandy Swann and I attended the first meeting of the Association of Ohio Health Commissioners' White Paper Opioid Committee on August 2, 2017. The committee will be establishing a set of guidelines for local health departments across the state to use when dealing with the opioid epidemic in Ohio. At this point, the committee is still deciding what role local health departments are to take, whether it should be a lead role or more of a support role in dealing with education, distribution of Narcan and treatment options, just to mention a few. The next call is set for August 22, 2017.

8) **Plumbing Program**

- The plumbing inspector for the city of Warren has indicated that he will be returning part-time; therefore, we will not be offering them plumbing services. We are still attempting to set up a meeting with the city of Warren to discuss possibly supplying plumbing inspection services to their city.



**Board of Health Report August 23, 2017, for June & July 2017**

- The Nursing Division has received three Notice of Awards (NOA) for the following grants: Prescription Drug Overdose Prevention grant - \$90,000 for September 1, 2017 through August 31, 2018; Tobacco Use Prevention Cessation Program grant - \$80,000 for July 1, 2017 through June 30, 2018; and Mom's Quit for Two grant - \$40,075 for October 1, 2017 through June 30, 2018.
- Frank Migliozi, Health Commissioner and Sandy Swann, Director of Nursing participated in the "PHEP Kick Off Meeting" for the 2018 PHEP grant on July 19, 2017.
- The Nursing Division is working with Mahoning County Board of Health (MCBH) to apply as a consortium for the Community Cessation Initiative grant which is a pilot program that works with established tobacco cessation programs to facilitate referral and follow up; facilitate the development of tobacco cessation programs; and evaluation of the success of these interventions. TCCHD would be a contracted agency of MCBH.
- All staff in the Nursing Division received Child Abuse Prevention Training on 07/17/2017.
- The Nursing Division has been working on marketing our adult immunization Vax-Care program and as part of that marketing we are periodically sending blast e-mails to our agency partners in Trumbull County. Attached is an e-mail sent by the immunization staff and a complimentary response from an employee who utilized our services.
- Attached is a copy of the overdose report for June and July 2017.
- The Nursing Division conducted our second annual Point of Dispensing (POD) drill on May 3, 2017 at Kent State University Trumbull Campus (KSUTC). Attached is the analysis of that drill. This was done in collaboration with our Medical Director, Warren City Health District, KSUTC, Trumbull County EMA, and Trumbull County Mental Health and Recovery Board. This drill enables us the opportunity to exercise setting up and operating a POD.
- Our DAWN Program has distributed 213 kits and 44 refills for 2017. There have been 16 responder kits used with 15 successful reversals and 1 unsuccessful reversal in June; and there have been 28 responder kits used with 27 successful reversals and 1 unsuccessful reversal in July.






# Trumbull County Overdose Report

## July 2017

During the month of July, the Trumbull County Combined Health District (TCCHD) has dispensed 47 Project DAWN kits and have given 4 refills to family and friends in the community. There have been 47 people trained to safely and effectively administer Naloxone. First responders have been given refills 32 times and have used 28 kits with 27 successful reversals. TCCHD also had a second group training for the employees of Trumbull County Children Services. Thirty nine (39) employees were trained, Naloxone is available at the agency and they are also carrying kits in the community. The training was held at the agency due to the “40% increase in kids coming into custody since 2015 because of the opiate crisis” according to Tim Schaffner. The agency felt a need to be pro-active so that if the worst happened and a parent came in for a supervised visit and overdosed they would be equipped to react to the situation safely and effectively. Thankfully, agencies and individuals in the community are stepping up to obtain a Project DAWN kit and be equipped to fight this epidemic and save a life.



Gender distribution of overdose-related ED visits; Trumbull County; July 2017







Chart of overdoses from July 2016 to present.

On Wednesday, May 3, 2017, a POD throughput drill was conducted at KSU Trumbull Campus. TCCHD nursing staff, WCHD nursing staff, TCMHRB staff, and the KSU TC Nursing Instructor met on March 29, 2017 to plan for this event.

TCCHD took the lead to develop and update all of the materials that would be used during the drill and WCHD took the lead to obtain the placebo medicine that was dispensed during the drill. In addition, TCCHD used Real Opt to set up a POD site derived from our planning discussions and modeled a through put time based on the number of stations designated and the number of people that would be available to manage each station.

Prior to the day of the drill, the KSU Nursing Instructor provided education to her students on the scenario agent, Anthrax, so that they would be familiar with this agent for this event. Also, TCCHD provided education on the Incident Command System (ICS) to the KSU TC nursing students.

TCCHD moved our Emergency Trailer to the site of the POD drill since it contains many supplies we would take to a POD if needed. TCCHD Nursing and Environmental staff prepared the trailer for its transportation to the drill. This in itself was a good training because it allowed us to realize the time it takes in preparing and moving the Emergency trailer. This time would need to be factored in during an emergency.

The drill was held on Wednesday, May 3, 2017 from 10:00 a.m. to 1:00 p.m. TCCHD and WCHD staff arrived early that day to set up the stations that would be used during the drill according to our Real Opt Plan. The students arrived at 10:00 a.m. and there were fifteen (15) students that participated.

The POD consisted of four throughput stations: 1) Registration Station; 2) Screening Station; 3) Dispensing Station; and 4) Exit Station; and one 5) Medical Review Station and one 6) Mental Health Station. Each of the throughput stations had at least two staff from TCCHD and/or WCHD who coached the students working at that station. There were at least two KSU nursing students assigned to each of the four throughput stations; one TCCHD staff assigned to the Medical Review Station; and two Mental Health and Recovery Board (MHRB) staff assigned to the Mental Health Station.

The following is an overview of each station:

1. Registration Station – this is where the person would complete the NAPH form. This station could be staffed by non-medical licensed personnel.

2. Screening Station – this is where the person’s NAPH form was reviewed and screened by a nurse for completion and medical contraindications. This station would be staffed with nurses or licensed medical personnel.
3. Dispensing Station – this is where the person would receive their medication and instructions. This station would be staffed with nurses or licensed medical personnel.
4. Exit Station – this is where the person would be asked to repeat the instructions they were given when they received the medication and also asked if they had any questions prior to leaving the POD. This station could be staffed by non-medical licensed personnel.
5. The Medical Review station would be assigned to a Medical Director or licensed individual who could provide an alternate medication prescription to someone who would not be able to take the medicines provided by the SNS assets. Persons who had any contraindications or there was uncertainty at the dispensing table went to this station. It was located out of the flow of the throughput.
6. Mental Health Station – is where someone that is anxious or upset could go to receive reassurance or counseling by Mental Health staff, such as licensed social workers, counselors, etc.

There was a “First Aid Station”, also located out of the throughput area, but it was not assigned nor used. It would be staffed with licensed individuals who would be able to provide assistance to anyone at the POD that might have a medical issue.

TCCHD provided a brief overview of the Anthrax scenario that was taking place in the community. Afterward, the nursing students were divided into two groups: one group of six and one group of nine. One of the groups would work the stations and the second group would be given a person they would portray to be processed through the POD.

The first group assigned to work the stations was divided so that there were at least two students at each of the four throughput stations. There was time allowed for “just in time training” for those students working the stations before the students portraying the people arriving at the POD were allowed into the POD. Each person that entered the POD was assessed or “triaged” by a TCCHD staff regarding their health status. This was to remove those who might be ill from the POD.

Once the first group completed the POD throughput, we reassembled in a second room so the students could flip their roles, and once the second set of students completed the throughput, a hot was conducted.

The following is the results of the hot wash:

#### **What went well?**

- Efficiency of the throughput;
- Well organized;
- Adequate “just in time” training;
- Good team work and being pro-active;

- Forms were easy to navigate;
- Good verbal instruction with handout reinforcement;
- Good verbal cues/escorting to the stations; and
- Good having a greeter.

**Opportunity for Improvement:**

- Have a sign at the door with instructions for people that are ill;
- The NAPHA form needs to have an “other” box for gender;
- Have an interpreter available;
- Assign a worker to escort a person who has a disability or small children;
- Don’t identify or bring attention to people that need mental health;
- Have hand sanitizers available;
- Have medicines names, contraindications, and alternative on one sheet and color code them.

At the end of the hot wash, the students gathered outside to see the Emergency Trailer and learn about the use of the trailer. They also completed a survey that was analyzed. Attached is a copy of the survey results.

On the NAPHA forms, we tracked the times the students entered the POD and exited the POD as well as the time spent at each station. This information will assist us to complete our required Public Health Emergency Preparedness (PHEP) data for the Dispensing Throughput drill; as well as compare to the time calculated by the Real Opt modeling system.

The following is the mean and median time for the throughput for each group:

**Group 1 (six students):**

Mean – 11 minutes  
Median – 10 minutes 30 seconds

**Group 2 (nine students):**

Mean – 17 minutes 12 seconds  
Median – 14 minutes

The Real Opt times that were calculated for the same POD set up was 15 minutes 4 seconds with +/- 2 minutes 51 seconds.

As you can see, our drill throughput was within the parameters set by Real Opt; and the larger group took more time; which is a factor to consider since there might be more issues when there are more people going through the POD.

## 911 Special-Needs Registry

The Trumbull County Commissioners and 9-1-1 Director, Ernest Cook, have recently launched a voluntary special needs registry that will help first respondents to better assist in emergency situations. A matter of minutes and even seconds can make the difference between life and death. Many people may need extra help during a time of emergency, including people who use life support such as oxygen, respirator, ventilator, dialysis, pacemaker, insulin, have mobility disabilities; are visually or hearing impaired; have speech, cognitive, developmental or mental health issues; or use assistive animals or prostheses.

## Trumbull County MetroParks

Although the existing phases of the Western Reserve Greenway (WRG) have been around since 2004, the effort to develop the trail began in 1989 with a committee of citizens and park experts. The committee formed into the Great Ohio-Lake-To-River Coalition which meets quarterly and collaborates to solve problems and share information. Though the process of laying path way can be quick, the efforts to attain funds necessary can be daunting. In 2011 funding for the Trumbull County portion of the Western Reserve Greenway was difficult.

In later years with changing political priorities and partnerships adequate monies were secured for development. In 1997 MetroParks entered into a 15 year lease to attain 153 acres of the former Penn Central 714 rail right of way. The first phase of approximately 8.3 miles of 10 foot wide asphalt trail opened on November 10, 2003.

The second phase which extended 6.3 miles north to the Ashtabula County line opened on November 10, 2004. Phase III opened officially in 2014. The WRG has been the MetroParks most successful project yet. The trail has historical locations, and people are urged to use several modes of transportation including horses along the trail. Members of the MetroParks Bike Patrol volunteer to help visitors on the trail. Signage notifies visitors of intersecting public roads, and benches are available along the entire route.

Maintaining the multi-million dollar trail can be daunting at times. The Trumbull County MetroParks continues to administer the development, grant writing and management phases of Phase IV on behalf of the Trumbull County Commissioners. Construction of the trail is anticipated 2020. The Warren Bikeway was completed in 2013 and uses abandoned rail rights, city streets, and underutilized properties. Warren The City of Warren has a 4 mile trail completed in 2012.

The World of Wildlife Bicycle Tour takes place yearly on the Western Reserve Greenway bike trail. Part of the ride is 20, 40 or 69 miles routes which pass through sections of wetlands and home to wildlife. Ride proceeds benefit the Trumbull County portion of the Western Reserve Greenway Phase Four, the section to be completed between Warren and Niles. Since the first ride in 2005 more than \$76,000 has been raised.

The Creating Healthy Communities Coalition work to increase/improve opportunities for physical activity within the community. The bike trail is a great place for individuals and families to get out and enjoy the weather, get some exercise and have fun. The best part is that it is free! In 2016 CHC Intern, Michael Helco, evaluated the bicycle/pedestrian infrastructure in Warren. Road and sidewalk conditions, daily pedestrian traffic, safety, lighting and other variables were considered as part of the evaluation. Recommendations from the evaluation include more lighting, more bike racks, safer road conditions and cleaner paths. Improving this infrastructure will encourage more community members to use the bike paths. In the 2018 grant year, CHC will be working with community stakeholders to make some of the suggested improvements.

While the warmer weather conditions may be ideal for outdoor picnics and barbecues, the summer months typically see a spike in reports of foodborne illness. Make sure your fun in the sun doesn't get cut short by following some simple summer entertaining tips:

### Basic Tips

CLEAN

CLEAN SURFACES, UTENSILS AND HANDS WITH SOAP AND WATER. If you're at a picnic, bring moist towelettes to use!

Wash all produce under plain running water before eating, cutting or cooking, even if you plan to peel them.

SEPARATE

SEPARATE PLATES AND UTENSILS. When grilling, use separate plates and utensils for raw and cooked meat and poultry and ready-to-eat foods (like raw vegetables).

COOK

USE A FOOD THERMOMETER. **Burgers: 160°F**

Just because your burger is brown, not pink, doesn't mean it's safe to eat!

CHILL

CHILL RAW AND PREPARED FOODS PROMPTLY if not consuming after cooking.

Don't leave food at room temperature for longer than two hours (or 1 hour if it's above 90°F). If planning a picnic, perishable food should be kept in an insulated cooler packed with ice or ice packs.

## What Are You Making?

Here are some food safety tips for preparing a few signature summer dishes.

### BARBECUE

Cook all meat and poultry to recommended internal temperatures.

Burgers: 160°F.

Chicken and Turkey: 165°F.

Sausage: 160°F.

Steaks: 145°F with a 3-minute rest time.

### FRUIT SALAD

Rinse all produce before peeling or chopping.

Chop all produce with clean knives on cutting boards not used with raw meat to avoid cross-contamination.

### DEVILED EGGS

Refrigerate prepared eggs until they're ready to be served and once out, keep them nestled in ice to keep them cool.

The Trumbull County Combined Health District has authority to license and inspect food operations within Trumbull County with the exception of those in Warren City. The purpose of these inspections is to ensure a safe dining experience for our residents. The licensing period runs from March 1 through February 28. To date, we have licensed 883 food operations for the current licensing period.

During the first quarter (March through May), our inspectors completed 357 inspections. The inspectors found 568 violations with 19 being critical. This equates to 1.6 violations per facility. All the critical violations are corrected before the inspection is complete.

Our inspection reports are public record and can be viewed upon request.

## **DID YOU KNOW...**

The Trumbull County Combined Health District offers adult vaccines, such as Tdap, Zostavax (shingles) and Pneumonia/Prevnar (as well as a few others)? We have contracted with a company called Vaxcare to provide vaccines to adults, age 19 and older. This company will bill your insurance company for eligible vaccines and vaccines determined to be a covered benefit will be administered by us at no charge. Copays and deductibles will be billed directly to you from Vaxcare. Insurance eligibility will be determined when calling for an appointment, and if vaccines are not a covered benefit, a self-pay option will be available.

### The Ongoing Fentanyl Crisis:

Trumbull County is seeing an increase in synthetic Fentanyl being added to the Heroin circuit in the county. First, we were informed of Carfentanyl (the animal tranquilizer), and now we are seeing two new forms of Fentanyl: Acryfentanyl and Furanyl Fentanyl U4770. These were actually discovered in toxicology results of two overdose death victims in the county. The U4770 form is also a component of the drug called "Gray Death." We are currently seeing an increase in Fentanyl over Heroin in those that have lost their battle with this deadly disease. In the deaths that have been reviewed in 2017, so far 32% of those individual were positive for Heroin and 64% were positive for some form of Fentanyl as well as other drug combinations. The other 4% were various combinations of drugs such as Cocaine, Benzodiazepines, Alcohol and Oxycodone. So unfortunately when someone buys drugs on the street today, they truly do not know what they are getting. These drugs tend to be much stronger and more potent than anything we have seen so far and are increasing the need for more doses of Narcan to reverse a person's overdose.

Data collected by the Trumbull County Combined Health District in 2016 shows more than 350 Narcan kits were dispensed by the health department, and "Out of those, we are aware of only 10 kits being used on individuals that had previously received Narcan to reverse their overdoses," said Kathy Parrilla, RN. There is a misconception that these same individuals are being revived over and over. According to the Mental Health and Recovery Board, addiction treatment agencies are staying full, which means people are getting help in recovery.

### THE RISK OF DISEASE RELATED TO SUBSTANCE ABUSE

Substance abuse drastically increases a user's odds of contracting life changing disease like HIV/AIDS, Hepatitis B & C, Tuberculosis, and STDs. Risky behaviors such as sharing needles, reusing drug paraphernalia, and sexual behaviors make for a high potential for disease contraction. Once a hard drug abuser is infected, diseases progress quickly and can lead to severe illness or death. Drug abuse weakens the body's immune system and makes users more likely to engage in risky behavior, either to attain drugs or while under the influence. Diseases linked to substance abuse are frequently serious and sometimes fatal. Certain drugs are linked to higher rates of disease among users than others. Diseases caused by drug abuse could be a direct result of the drug use or behaviors that occur under the influence. Addiction treatment and community outreach programs that prevent substance abuse and promote safer drug-using habits can be extremely effective in preventing the spread of disease and STD's.



**Needlestick Injuries – A Community Concern**



There are concerns that members of the general public may be at increasing risk of infections from injuries caused by used needles/syringes discarded by persons legally self-injecting medication and disposed needles/syringes that have been found, reused and re-discarded by persons illegally self-injecting addictive substances. These concerns have led to guidelines for safe needle/sharp disposal. Needlestick injuries occur in children from discarded needles in community settings, such as parks and playgrounds. There are a number of ways needlestick injuries can be prevented first and foremost, increased education in the community is vital. Ohio EPA has information on handling needles/syringes. Children should be taught at a young age about the risks of handling needles and the correct actions to take if they find one. Teach them never to touch a needle/syringe, they may carry diseases. Tell them to let an adult know if they find one. When finding a needle/syringe, do not handle it, or try to bend or break off the needle. Find a hard, puncture proof container, take the container where the needle is found, using gloves or tongs carefully pick it up and place in the container. Secure and seal the lid, and following Ohio law, place the container in the local trash. Wash your hands with soap and water. You can also call your local police department.

**Childhood obesity is a major public health problem.**

- Children who have obesity are more likely to have obesity as adults. This can lead to lifelong physical and mental health problems, including diabetes and increased risk of certain cancers.
- Children who have obesity face more bullying and stigma
- Childhood obesity is influenced by many factors. For some children and families factors include too much time spent in sedentary activities; such as television viewing; a lack of bed time routine leading to too little sleep; a lack of community places to get adequate physical activity; easy access to inexpensive high calorie snacks and beverages; and/or a lack of access to affordable, healthier foods.

**There are ways parents can help prevent obesity and support healthy growth in children.**

- To help ensure that children have a healthy weight, energy balance is important. To achieve this balance, parents can make sure children get adequate sleep, follow recommendations on daily screen time, take part in regular physical activity, and eat the right amount of calories.
- Parents can substitute higher nutrient, lower calorie foods such as fruit and vegetables in place of foods with higher-calorie ingredients, such as added sugars and solid fats.
- Parents can serve children fruit and vegetables at meals and as snacks.
- Parents can ensure access to water as a no-calorie alternative to sugarsweetened beverages.
- Parents can help children get the recommended amount of physical activity each day by encouraging them to participate in activities that are age-appropriate and enjoyable. There are a variety of age appropriate aerobic, muscle and bone-strengthening activities that kids can do.



**Mission:** To prevent childhood overweight and obesity and promote healthy weight and growth in all children in Ohio, starting with the youngest age group—birth to five years old.

### Certified Centers

- Offer a different non-fried vegetable everyday.
- Offer a different fruit everyday (not counting juice).
- Offer a whole grain food everyday
- Offer fried foods no more than once a week
- Only offer beverages without any added sugar or sweeteners. If juice is offered, it is 100% juice no more than once a day and limit portion to 4- 6 oz.
- If cereal is offered, it must have 6 grams sugar or less per serving (WIC-approved cereals).
- Do not serve these highly processed meats: corn dogs, hot dogs, frankfurters, bologna, pepperoni, polish sausage, salami, summer sausage, and liverwurst
- Encourage and provide opportunities for physical activity throughout the day.
- Family engagement component.

increasing the **RISK** of more than **20 PREVENTABLE CONDITIONS**, including sleep apnea, asthma, heart disease, Type 2 diabetes, osteoarthritis, high blood pressure and high cholesterol stroke.

## RISK FACTORS

- Children in their early teens who are obese and who have high triglyceride levels have arteries similar to those of 45-year-olds.
- Obese children as young as age 3 show indicators for developing heart disease later in life.
- Children who are overweight from the ages of 7 to 13 may develop heart disease as early as age 25.
- Obese children are twice as likely to die before age 55 than their slimmer peers.



## August is Breastfeeding Awareness Month

### **Communities Need to Work Together to Provide Support for Breastfeeding Mothers**

In support of this year's theme, Trumbull County WIC is hosting "The Big Latch On" Event August 4 at 10a at the Trumbull County WIC office, 258 East Market St. Suite 201, Warren, OH 44481. Women gather together to breastfeed and offer peer support to each other. This event is a celebration of breastfeeding mothers and the team that supports them. Trumbull County WIC is dedicated to helping clients make and meet their goals for breastfeeding their children. WIC breastfeeding peer helpers all have personal experience with breastfeeding their own children and can share how they made it work for their families. They also have the training needed to answer questions and help mothers succeed at breastfeeding. The breastfeeding peer helpers are all Certified Lactation Counselors (CLC). They do yearly trainings to stay up to date on the latest breastfeeding information to help mothers get off to a good start with breastfeeding, and answer any questions they have. We also have a full-time International Board Certified Lactation Consultant (IBCLC) that leads the breastfeeding team. She has been with WIC for many years and can help with complex breastfeeding situations and conduct breastfeeding assessments.

The American Academy of Pediatrics (AAP) and the World Health Organization (WHO) recommend exclusive breastfeeding for the first six months of life and continued breastfeeding with the addition of appropriate solid food for the first year and beyond. In light of the monetary and lifesaving benefits of breastfeeding, all elements of the community, must cooperate and support breastfeeding. Ultimately, our whole society benefits from having healthy mothers, babies and children when breastfeeding is promoted, protected and supported.

One of the most important things businesses and the community can do is to allow mothers to feel comfortable nursing in public. Hungry babies need to eat and Ohio law (*Section 3781.55 of the Ohio Revised Code*) allows breastfeeding in public. Businesses can show their support by placing the "Breastfeeding Welcome Here" universal sign for breastfeeding in their windows and educate their staffs on the acceptance of breastfeeding in their establishments. They can also encourage their employees and provide a private space (other than a bathroom) to pump. This will increase employee retention and reduce medical costs.

Hospitals can adopt the *Ten Steps to Successful Breastfeeding* as an indication that they are dedicated to supporting new mothers who choose to breastfeed. By declining formula gifts to breastfeeding mothers, they send the message that they believe mothers can make enough milk to breastfeed exclusively.

Educational institutions can support breastfeeding by presenting age appropriate education on the anatomy and physiology of the human body. Local county fairs can teach young children about how other mammals feed their young with milk that is made just for them. Child care providers and libraries can also stock children's books that show breastfeeding as a normal part of family life.



Breastfeeding is a personal choice, but communities play a vital role in informing and supporting a mother's decision to breastfeed her baby. Returning our communities back to a breastfeeding supportive culture will take efforts by family, friends, employers, educational institutions, hospitals and businesses.
